Buprenorphine (Subutex)-2017

Naltrexone (Vivitrol)-2018

Opioid Treatment At SRHD

- Began at SRHD in 1990
- 275 patients on program in 2006
- Currently 950 patients and increasing
- Minimal “wait list” for initial assessment
- \$457.50 per month, per patient
- Brain Disease
- Harms Reduction Model
- Goals –
 - Reduce withdrawal symptoms
 - Reduce cravings while engaging patients in treatment
 - Assess patient medical issues/needs
 - Monitor patient health issues/refer to community providers for medical and dental

Off Site Dosing

- 2017 began dispensing at Spokane County Detention Services (Jail)
- Dispensing to currently admitted patients to OTP
- Pregnant women not enrolled, assessing and enrolling to dispense
- Working with SCDS to offer inmates initial assessment and enrollment.

Financial

- **\$5.4 million -2018 budget**
- **Fee based program**
 - Medicaid
 - Grants
 - Veterans Administration Contract
 - Private Insurance-1 contracted at this time
 - Private Pay
- **No local dollars used**
